Discounted Registration Deadline

The deadline for discounted early registration is Wednesday, January 17, 2018. Register by this date for the best value.

Discounted Registration Fees

APhA offers discounted registration fees for new practitioners, technicians, post-graduates/residents, and students. No other promotional offers or discounts apply to these categories. Early bird rates (before January 17) offer all categories the greatest savings!

Purchase Orders

APhA will accept purchase orders from federal government agencies and military institutions only. Purchase orders will be accepted via mail and fax (not via the internet) and must be submitted with a completed registration form. You must provide a credit card guarantee with your initial registration and purchase order. If the check isn't received within 30 days after the meeting, your credit card will be charged for the full amount.

Cancellations

All registration cancellations must be in writing. Cancellations received by February 17 will be refunded less a \$100 administrative fee. No refunds will be made for cancellations received after February 17. Ticketed event fees are non-refundable except when an event is cancelled by APhA.

Confirmations and Badges

Registration confirmations will be sent via email within two business days of receipt of your registration. Badges and tickets will be distributed on site. Review your confirmation thoroughly to ensure your registration includes everything you are expecting.
