What is **target marketing**? Target marketing is defining the specific audience you want to reach at a trade show and doing everything necessary to draw that audience to your exhibit. APhA will provide a complimentary list (in excel format) to each exhibiting company to use for a one-time pre-show mailing.

\*Each list will contain 2,000-4,000 names and complete mailing addresses and can be sorted by last name or by zip code. E-mail addresses are not included.

**Using up-to-date membership and pre-registration lists, APhA will provide an electronic file of one of the following target marketing lists:**

- 1) Want to invite pharmacists who are pre-registered for APhA2019 and invite them to visit your booth? Then purchase the pre-convention registration list for \$1,000. The list does include e-mail addresses.
- 2) Looking only for local area pharmacists? The **Regional List** includes members located within a one day drive of Seattle, Washington. *Complimentary list.*
- 3) Looking for pharmacist decision-makers? The **Nationwide Managerial List** contains staff pharmacists, managers, supervisors, owners, directors of pharmacy and presidents of both chain and independent pharmacies. *Complimentary list.*
- 4) Want to reach new practitioners nationwide? Order the APhA **New Practitioner List!** These pharmacists are new practitioners and represent pharmacists in the early part of their careers (members eligible up to 5 years after they graduate). *Complimentary list.*
